Agreement between Sponsor and Exhibitor

(the fine print)

The undersigned (the "Exhibitor") hereby requests space at the camera/photographica show and sale to be sponsored by C.A.M.E.R.A. (the "Sponsor") at the time and place specified herein.

1. By completing and signing the application form below, the Exhibitor agrees that if his/her application is accepted by the Sponsor, he or she will comply with all of the following:
 - (a) The Exhibitor's table(s) shall be maintained during the period from 10 A.M. to 3 P.M. when the show is open to the public. Only photographic related items may be displayed. If the Exhibitor intends to arrive after 10 A.M. or leave before 3 P.M. he/she shall notify the Sponsor prior to the assignment of tables on the deadline date indicated below.
 - (b) Setup time commences at 8 A.M. The Exhibitor shall begin set up no later than 9:30 A.M. Failure to do so may result in table space forfeited and the Sponsor may reassign or otherwise utilize the space. In such event, the Exhibitor shall not be entitled to any refund of any deposits or other payments made to the Sponsor.
 - (c) The Exhibitor shall comply with all applicable Federal, State, and Local laws, and with all rules, regulations and directions of the management of the building in which the show is held. The Exhibitor must have a valid New York State Sales Tax Collection Permit.
 - (d) The Exhibitor shall clearly state the terms and conditions of any guarantee applicable to items offered for sale, including representations of quality or authenticity. Items that are sold "as is" shall be clearly represented or marked as such.
 - (e) The Exhibitor shall be entitled to two ID tags per table. No person shall be admitted to the show area during setup without an ID tag. The Exhibitor shall be responsible for all acts of his/her employees or assistants, or any person wearing the ID tag assigned to the Exhibitor.
 - (f) The Exhibitor shall be responsible for the protection of his/her merchandise and the Sponsor shall have no responsibility for any damage or loss due to theft, vandalism, accident, fire or any other cause.
 - (g) The Exhibitor agrees to indemnify the Sponsor and hold it harmless from any and all claims including, without limitation, loss or damage to property and/or personal injury arising out of the Exhibitor's participation in the show under this agreement.
2. The Exhibitor shall make payment to the Sponsor of the charges specified in the application form at the same time such application is submitted.
3. All applications shall be subject to acceptance by the Sponsor. If an application is accepted, the Exhibitor will be notified. If accepted, the Sponsor will provide the Exhibitor with the use of tables and chairs at no additional fee. If an application is not accepted, any moneys paid with it will be returned in full.
4. If for any reason the show is cancelled, or the Sponsor is unable to provide space to an Exhibitor, the Sponsor will return in full all moneys paid to it hereunder by the Exhibitor and Sponsor shall have no further responsibility of any kind to the Exhibitor.
5. The Sponsor shall have the right to immediately cancel any space allocated to an Exhibitor and all rights of an Exhibitor under this Agreement in the event such Exhibitor violates any of the terms or conditions of this Agreement, or in the event of any misconduct on the part of the Exhibitor or any of his/her employees or representatives. In such event, the Exhibitor shall not be entitled to any refund or any moneys paid and the Sponsor shall have the right to reassign the Exhibitor's space to others.
